WHAT DOES HONDA FINANCIAL SERVICES DO WITH YOUR PERSONAL INFORMATION?

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> • Social Security number and Income • Transaction History and Account Balances • Credit History and Credit Scores
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Honda Financial Services chooses to share; and whether you can limit this sharing.

Who is providing this notice?	Honda Financial Services a dba of American Honda Finance Corporation and its affiliates, which include financial and insurance companies.
What we do	
How does Honda Financial Services protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does Honda Financial Services collect my personal information?	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> - apply for a lease or provide account information - apply for financing or provide employment information - give us your contact information <p>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</p>
Why can't I limit all sharing?	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> - sharing for affiliates' everyday business purposes—information about your creditworthiness - affiliates from using your information to market to you - sharing for nonaffiliates to market to you <p>State laws and individual companies may give you additional rights to limit sharing. Please see below for additional information.</p>
What happens when I limit sharing for an account I hold jointly with someone else?	Your choice will apply to everyone on your account.
Definitions	
Affiliates	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> - <i>Our affiliates include companies with a Honda name and nonfinancial companies such as American Honda Motor Co., Inc., and Honda Aircraft Company, LLC.</i> - <i>Under California law, authorized independent Honda dealerships are also considered "affiliates."</i>
Nonaffiliates	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> - <i>Nonaffiliated companies include authorized independent Honda dealerships that have a contractual relationship with affiliates of Honda Financial Services.</i> - <i>Under California law, authorized independent Honda dealerships are considered "affiliates."</i>
Joint marketing	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> - <i>Honda Financial Services does not jointly market.</i>

Other important information

By providing telephone number(s) to us at any time, you authorize Honda Financial Services and its affiliates and designees to contact you regarding your account(s) (including any business accounts for which you are an authorized signer) at such numbers using any means, including but not limited to placing calls using an automated dialing system to cell, VoIP or other wireless phone number, or by sending prerecorded messages or text messages, even if charges may be incurred for the calls or text messages; and you consent that any phone call with us may be monitored or recorded by us.

State Privacy Laws: We will comply with state privacy laws to the extent they apply.

California Residents: We do not currently share your nonpublic personal information with nonaffiliates for them to market to you. If our practice changes, we may obtain your consent through another notice. You may opt-out of certain sharing with affiliates (including Honda and Acura dealers) on this form and/or by returning the enclosed Important Privacy Choices for Consumers form.

Vermont Residents: We will not disclose information about your creditworthiness to our affiliates and will not disclose your personal information, financial information, credit report, or health information to nonaffiliated third parties to market to you, other than as permitted by Vermont law, unless you authorize us to make those disclosures.
